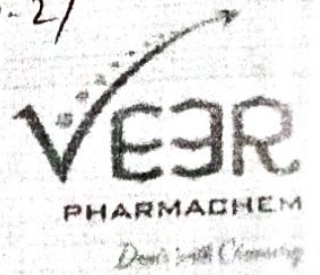

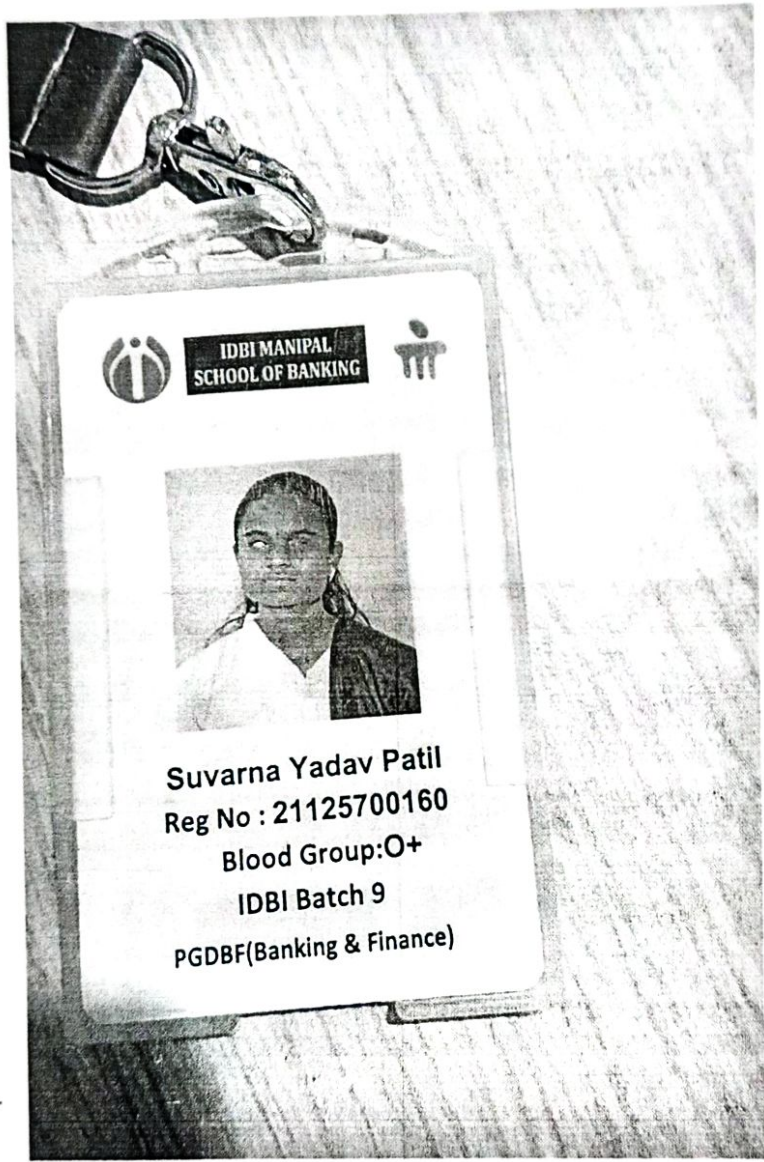

Mumbai vide email dated 22.01.2021 and C.O. letter No. Rectt/2/SLP 22969-22976/2019 dated 29.01.2021 conveyed by R.O. Mumbai vide email dated 29.01.2021 and R.O. Mumbai memo No. MR/STA/Misc-Rectt/Postman-MTS/2015-16 dated 02.02.2021 and Directorate letter No. W-04/2/2020-SPN-I-Part(1) dated 19.10.2020, **Shri Swapnil Shivaji Kalankar** is provisionally appointed as **Postman** as shown below with immediate effect in the Pay Band of 5200-20200 (GP 2000) Pay Matrix Level 3 plus allowances as admissible from time to time. This provisional appointment is subject to satisfactory verification of the prescribed educational qualification, police verification, community certificate and other certificates / documents wherever prescribed. The candidate will have to undergo prescribed Institutional Induction Training and Practical Training as and when order issued.

The selected candidate will be on probation for the period of Two years from the date of his appointment, which may be extended at the discretion of Competent Authority. If the work, conduct and character of the candidate is not satisfactory in the opinion of the Competent Authority, his services will be terminated at any time without assigning any reasons by a notice of one month in advance or forthwith by payment of a month pay. The Competent authority however reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payments to him a sum equivalent to the pay and allowances for the period of notice or un-expired period of thereof, if any, if the terms and conditions are not fulfilled.

On completion of probation period, the Sr. PM / Sub Postmaster concerned will furnish report regarding work and conduct of the candidate to this office. He will be governed by the provisions of CCS (Temporary Services) Rules, 1965 as amended from time to time and will not confer any title for permanent appointment.

The appointment is provisional and subject to submission of Caste Validity, Verification of Caste/Tribe/Community Certificate and Police Verification through proper channel and till completion of the probation period with satisfactory result. If the verification reveals that the claim of belonging to SC/ST/OBC, as the case may be is false, the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of Indian Penal Code for producing of false certificate. The candidate will submit the Caste Validity / Verification preferably within a period of 6 months from the date of appointment. The Appointment carries with the liability to serve in any post office under Mumbai East Division to which **Shri Swapnil Shivaji Kalankar** may be posted. In case of bifurcation of this division, **Shri Swapnil Shivaji Kalankar** is liable to be transferred to any other division as per the orders of the Competent Authority.

Other conditions of the services will be governed by the relevant Rules and orders issued from time to time.


On appointment, **Shri Swapnil Shivaji Kalankar** will be required to take an oath of allegiance to the constitution of India or to make a solemn affirmation to effect in the prescribed forms.

New Pension Scheme (NPS) came into effect from 01.01.2004. New Pension Scheme is mandatory for the recruits and the monthly contribution would be 10% of the Salary and DA to be paid to him or the amount prescribed by the Govt. of India from time to time and will be recovered by the drawing officer as monthly contribution for pensionary benefits.
