Certificate Course in Goods and Service Tax

Annual Report Academic Year-2020-21

This is the second year that college running the Certificate Course in Goods and Service Tax which is self-financed course sanctioned by KBC NMU Jalgaon started from the academic year 2018-19. At the time of admission of the classes of M Com, the students were oriented the course and its application in current time. In the beginning of the academic year the notice was issued to the students of M Com classes, out of which of 17 students admitted for the course. The fees structure of the course is defined as per the guidelines of the university i.e. Rs. 1000/-.

Apart from the regular lectures, in the beginning of the academic year the separate schedule for the lectures of the course was prepared and accordingly lectures were conducted by the regular faculties of the college and guest lecture by experts in GST. Simultaneously the topics for projects were given to the students and accordingly they prepared the projects on GST. Based on their project, internal examination, attendance, class participation etc. internal assessment of the students was carried out. The final university examination of the same course was scheduled and conducted by university itself.
